SECTION I: DECLARATION OF PURPOSE - This local law is intended to provide that the agricultural assessment provided for in Section 305 of the Agriculture and Markets Law of the State of New York shall be used for the special ad valorem levy of the Enfield Fire District.

SECTION II: AUTHORIZATION - The Town of Enfield Fire District is hereby authorized to use the agricultural assessment determined pursuant to Section 305 of the Agriculture and Markets Law of the State of New York, as amended by Chapter 562 of the Laws of 1991, for the special ad valorem levy for such district.

SECTION III: EFFECTIVE DATE - This local law shall take effect immediately.
