RESOLVED, the Town Board authorizes the Supervisor to decrease "Highway Equipment Reserve", line DA231 by \$2,550.00, and increase "Machinery – Equipment", line DA5130.2 by \$2,550.00.

Budget Amendment #2018-29Move Funds for Clean Earth Septic

WHEREAS funds are needed for pumping at the highway facility, therefore be it

RESOLVED, the Town Board authorizes the Supervisor to decrease the Contingent Account line A1990.4 by \$200.00 and increase Garage Contractual line A5132.4 by \$200.00.

Budget Amendment #2018-30 Move Funds for Highway Bond Filing Fees
