**RESOLUTION # 2024 - \_\_\_\_ A Proposed Local Law to amend the Town’s existing dog licensing and control law**

**WHEREAS**, The Town of Enfield is updating Town’s existing dog licensing and control law to update dog licensing fees and make other administrative changes; and

**WHEREAS**, a public hearing was held before the Enfield Town Board on Ju 12, 2024, to hear all persons interested in proposed Local Law No. \_\_\_\_ of 2024, now therefore be it

**RESOLVED**, That Local Law No. \_\_\_\_ of 2024 A Proposed Local Law to amend the Town’s existing dog licensing and control law is hereby adopted by the Enfield Town Board,

**RESOLVED**, further, that the Enfield Town Clerk shall publish in the official newspaper of the Town a notice of adoption containing a synopsis of said local law and shall within twenty days file one certified copy in the Office of the County Clerk, and one copy with the Secretary of State.

**Resolution # \_\_\_\_-2024 Establishment of the Enfield SkateGarden**

**WHEREAS**, youth in the Town of Enfield have expressed more recreational opportunities in the Town, specifically a skate park; and

**WHEREAS**, the Town of Enfield was awarded a \$5000 grant through the Tompkins County’s 2024 Municipal Parks and Trails Grant Program toward the construction of the skate park; and

**WHEREAS**, additional funds have been secured through a Tompkins County Beautification Grant to plant a Pollinator Garden; now therefore be it

**RESOLVED**, The Town Board of the Town of Enfield hereby designates the property at 169 Enfield Main Rd as the location for the Skate Park and Pollinator Garden to be known as the Enfield SkateGarden
